NIALS ENABLING ACT

Commencement Establishment of the Nigerian Institute of Advanced Legal Studies

- (1) There is hereby established an institute to be known as the Nigerian Institute of Advanced Legal Studies (in this Act referred to as "the Institute") which shall have the functions assigned to it by this Act.
 - (2) The Institute shall be a body corporate with perpetual succession and a common seal and may sue and be sued in its corporate name.

MEMBERSHIP OF THE COUNCIL, etc.

- (1) There shall be established for the management of the affairs of the Institute a body to be known as the Nigerian Institute of Advanced Legal Studies Council (in this Act referred to as "the Council")
 - (2) The Council shall consist of the following members, that is (a) a Chairman to be appointed by the President;
 - (b) a representative of the Federal Ministry of Justice;
 - c) a representative of the Federal Ministry charged with responsibility for higher education;
 - (d) six Deans or Heads of Faculties, or other formations



of Nigerian Universities offering degree courses in law at not less than post-graduate level, to be appointed by the President; the Director-General of the Nigerian Law School; one member of the Judiciary nominated by the Chief Justice of Nigeria; the President of the Nigerian Bar Association; five persons of whom one shall be a woman to be appointed by the President; and the Director-General of the Institute.

(3) The provisions of the Schedule to this Act shall have effect with respect to the proceedings of the Council and the other matters therein mentioned.

FUNCTIONS OF THE COUNCIL

- (i) Council shall be responsible for the determination of the overall policy of the Institute and in particular for the financial and operational programmes of the Institute and for ensuring implementation of such policies and programmes.
- (ii) Without prejudice to the generality of subsection of this section, it shall be the duty of the Council to approve the research and training programmes of the Institute, determine the fees to be paid for research, consulting, training and any other services that may be offered by the Institute and promote or undertake any other activity that in the opinion of the Council is calculated to help achieve the purposes of the Institute.






2.1. HIGHLIGHTS OF TRADE POLICY OF NIGERIA (2023-2027)

Objectives of the Trade Policy 2023-2027

The Policy has one core objective and eight other specific objectives. The core objective is to increase the contribution of the trade sector to the GDP and global trade of Nigeria substantially so that the national economy can grow and develop progressively.

The other eight specific objectives include to:

- (a) reduce the dependence of the Nigerian economy on oil and gas, promote export of value-added manufactured products and generally diversify the economy;
- (b) develop an efficient and flourishing domestic market that is both competitive and integrated into the global economy;
- (c) take advantage of the size of the population of the country and the demographic as a positive economic force that will patronize made-in-Nigeria products; and create more jobs and reduce the rate of unemployment






Scope of coverage and application

The Policy is multi-sectoral and encompasses MDAs, States, civil society organizations and the stakeholders that have been identified in the institutional framework in figure 7.1 that are in one way or the other, connected with trade in Nigeria. The Policy applies throughout Nigeria within the purview of her rights and obligations under the various trade instruments identified within the Policy.

The Trade Policy 2023-2027 is a trade policy of the Federal Government prepared by the FMITI Federal Ministry as a mechanism to improve trade in Nigeria and boost the economy and foreign earnings aside from the oil sector, which is the primary source of foreign exchange. The Policy identifies sectors particularly within the rights and obligations of Nigeria under the WTO, AfCFTA, ECOWAS and other international agreements. It outlines goods and services that can be added value to enable Nigeria leverage on the opportunity to stimulate growth and development in her economy just like other emerging economies. It finally identifies an implementation strategy and action plan which if carefully followed, will result in the attainment of the core objective of the Policy.




2.2. HIGHLIGHTS OF NIGERIA AFCFTA IMPLEMENTATION STRATEGY

Objectives

The Strategy has eight core objectives which are described as pillars. They include:

- (a) productive capacity: which aims to grow the capacity of the Nigerian economy to produce and export competitively to the rest of Africa with focus on specific value chains of AfCFTA and Nigerian products and services;
- (b) trade facilitation: which aims to make Nigeria the best in Africa through the optimization and establishment of trade facilitation measures (such as automation of administrative procedures) to bring down the cost and time of trade by 80% by 2035;
- (c) trade policy: aims to ease access to African markets for Nigerian products, services, investments, and incentives for investment with the necessary safeguards against unfair trade practices;
- (d) trade related-infrastructure: which aims to leverage on innovative ways to enhance energy to power economic activities, rehabilitate and develop transportation infrastructure to move goods and persons across the borders and upgrade digital infrastructure;
- (e) trade Finance: which aims to facilitate access to funds and financial instruments and also harmonize regional and regulatory and risk management frameworks to expand financial opportunities that ease cross-border trade and investment across the continent; and
- (f) factor market integration: which aims to improve mobility of Nigerian natural, corporate persons and skills across Africa through policy initiatives such as reformation of immigration visa regime, and other initiatives as outlined in the Strategy.








Scope and Application of the Strategy

The scope of the Strategy extends to the historical background of the AfCFTA including its objectives, and the Framework Agreement establishing it, the macroeconomic, trade, production and competitiveness frameworks that exist in Nigeria. It also encompasses an analysis of the performance of the oil and non-oil sectors, critical factors that underpin the implementation of the AfCFTA including considerations regarding the Global Value Chains, the strategic institutional framework to implement the Strategy and the governance structure that will implement, administer, monitor and evaluate the Strategy. The Strategy applies to a wide range of stakeholders that are involved in trade in goods and services in within the purview of the rights and obligations of Nigeria, nationally, regionally and continentally under the AFCFTA Agreement including stakeholders like Governments both at the national and sub national levels, the private sector, the civil society, traders, investors, economic operators, and others.

The AfCFTA Agreement presents Nigeria with a phenomenal opportunity to achieve her national development plan, boost the growth and development of her economy and position made-in Nigeria goods and services to be accepted and sought after both within and outside Africa. It particularly affords Nigeria the opportunity to participate in the Global Value Chains of production which can create more jobs and grow goods and services beyond the oil sector. The objectives of the Strategy can be achieved provided Nigeria takes advantage of the issues identified within the Strategy and implements it through the governance structure followed by strict adherence to the Monitoring and Evaluation framework instituted within the Strategy.



2.3. Highlights of the Business Facilitation Act, 2023

- The BFA aims at enhancing transparency and efficiency of public service delivery
- Translating directly into greater productivity and competitiveness.
- Translating into increased EASE of DOING BUSINESS IN NIGERIA
- The BFA is a soft infrastructure which borders on regulations, transparency, communication and timelines (as opposed to traditional hard infrastructure such as roads and rails).
- The BFA is a strategic instrument that incorporated the key principles of Executive Order 001.






2.4. Highlights of the Nigeria Customs Service Act, 2023

- The NCS Act, 2023 repeals the Customs and Excise Management Act (CEMA) and other piece of legislations relating to Customs and Excise and provides the legal and institutional framework for the reform of the administration and management of customs and excise in Nigeria.
- The Act includes provisions that will enable the NCS to meet its key objectives such as revenue generation and collection, prevention and suppression of smuggling, collaboration with other relevant agencies, facilitation of international trade and economic development, valuation of good and determination of rules of origin of goods for the purpose of applying preferential and non-preferential rules. It encourages free movement of goods, provides tariff incentives for business engaged in environmentally friendly / sustainable practice (such as fishing methods, shipping friendly practices, responsible acquaculture in the blue economy of Nigeria and in international trade. It introduces simplified and transparent customs procedures for the import and export of goods and natural resources.)

2.5. National Gender Policy, 2021 - 2026

- The NGP incorporates the guiding principles contained in all the Continental and regional instruments mentioned earlier, namely: Gender Equality, Non-discrimination, participation in decision making process affecting women's live in society, in law, policy, economy, politics, trade investment, education, employment, family and leadership; gender mainstreaming in law and policy making and implementation; access to credit and access to justice for redress and compensation; women's rights as fundamental human rights in their social, economic, civil, political, cultural, environmental and developmental contexts.
- The NGP provides institutional framework at the federal, state and local levels; monitoring and evaluation framework as well as the roles of government, CSOs, private sectors, local communities, development partners and the academia in the strategic resource mobilization and implementation of the policy.
- The NGP is consistent with Nigeria's human rights treaty obligations under UN CEDAW and the AU Maputo Protocol on the Rights of Women in Africa.

1^{ST,} policies must ensure benefits of economic growth are EUITABLY distributed, with a particular focus on gender inclusivity and dismantling barriers that hinder the progress of women;

2^{nd,} the recognition by policy and lawmakers that the foundation of women's empowerment is deeply rooted in the principles of human rights (such as non-discrimination, participation, equality of rights and opportunities, access to market information, tools and finance);

3rd, CSOs and the academia need to engage the media and policymakers in understanding the fact that the upcoming AfCFTA Protocol on Women and Youth in Trade aims at focusing on the empowerment rights and roles of women and youth as entrepreneurs, exporters, importers, producers and cross-border traders; recognizing the importance of gender equality and the empowerment of women as key drivers for sustainable development; enhancing women's participation in trade to fulfil the core objectives of the trade agreement; improving the competitiveness of women in their various trade roles while addressing gender considerations in trade agreements;

4th, Women's empowerment in trade requires removing not only tariff and non-tariff barriers to trade, but also protection of labour rights (such as decent work and fair wages, equal pay for equal work) and eradication of labour exploitation (such as income inequality, unpaid caregiving work/duties, inability to balance work and family life) as well as enhancement of social safety nets to shield vulnerable populations, particularly women, from economic shocks (such as considering how majority of women in the informal sector can have access to paid maternity leave or old age pensions that can support them when they cannot work).





5th, by addressing economic, social and cultural barriers that Women Owned Business (WOBs) generally face when it comes to trade in particular: they lack access to networks, capital and knowledge of regional markets, market requirements and standards and regional supply chains; trade related and administrative procedures and red tapism are particularly burdensome due to time poverty, poor access to infrastructure and discriminatory practices at the border.

6th, by constantly reminding policy and lawmakers/decision makers/implementers that AfCFTA is a project in construction, a "blank canvass" opening a whole range of possibilities in its different operational phases. Hence Member States have shown the willingness to create room for women in trade by including gender in the creation process by including Article 3(e) into the AfCFTA Agreement which stipulates that the AfCFTA has a general objective to "promote and attain sustainable and inclusive socio-economic development, gender equality and structural transformation".

7th, by giving women the tools to stand up for themselves and put pressure on policy-makers to take their needs and issues into account, we are building the capacity of women engaging with the AfCFTA, fostering a culture of dialogue in which no one is left behind, and guided in our approach to "putting a Woman's face to the AfCFTA", by the UN SDGs related to poverty reduction (SDG-1), Gender Equality (SDG-5), and Decent Work and Economic Growth (SDG-8), as well as the AU Agenda 2063, the Africa we Want, that aims at creating a free of gender discrimination Africa by 2063.

The Director General commended the Nigerian Institute of Advanced Legal Studies' Committee members from Lagos and Abuja combined for screening and voting recipients for his approval.




