NIALS ENABLING ACT

Commencement Establishment of the Nigerian Institute of Advanced Legal Studies

- (1) There is hereby established an institute to be known as the Nigerian Institute of Advanced Legal Studies (in this Act referred to as “the Institute”) which shall have the functions assigned to it by this Act.
- (2) The Institute shall be a body corporate with perpetual succession and a common seal and may sue and be sued in its corporate name.

MEMBERSHIP OF THE COUNCIL, etc.

- (1) There shall be established for the management of the affairs of the Institute a body to be known as the Nigerian Institute of Advanced Legal Studies Council (in this Act referred to as “the Council”)
- (2) The Council shall consist of the following members, that is
 - (a) a Chairman to be appointed by the President;
 - (b) a representative of the Federal Ministry of Justice;
 - (c) a representative of the Federal Ministry charged with responsibility for higher education;
 - (d) six Deans or Heads of Faculties, or other formations



of Nigerian Universities offering degree courses in law at not less than post-graduate level, to be appointed by the President; the Director-General of the Nigerian Law School; one member of the Judiciary nominated by the Chief Justice of Nigeria; the President of the Nigerian Bar Association; five persons of whom one shall be a woman to be appointed by the President; and the Director-General of the Institute.

- (3) The provisions of the Schedule to this Act shall have effect with respect to the proceedings of the Council and the other matters therein mentioned.

FUNCTIONS OF THE COUNCIL

- (i) Council shall be responsible for the determination of the overall policy of the Institute and in particular for the financial and operational programmes of the Institute and for ensuring implementation of such policies and programmes.
- (ii) Without prejudice to the generality of subsection of this section, it shall be the duty of the Council to approve the research and training programmes of the Institute, determine the fees to be paid for research, consulting, training and any other services that may be offered by the Institute and promote or undertake any other activity that in the opinion of the Council is calculated to help achieve the purposes of the Institute.

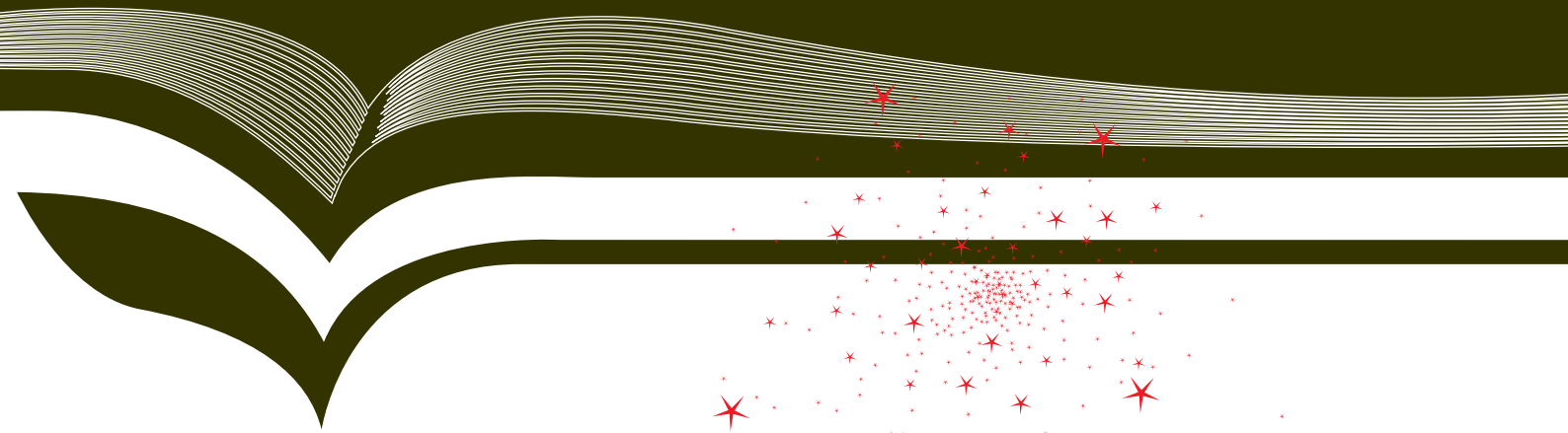

WELCOME REMARK BY THE DG NIALS, PROF. M. T. LADAN, AT THE OPENING SESSION OF THE WEEK-LONG ADVANCED CERTIFICATE IN INTERNATIONAL LAW AND DIPLOMACY, ORGANIZED BY THE INTERNATIONAL LAW ASSOCIATION (ILA) AND NIALS. 22 -26 JULY, AT THE SUPREME COURT COMPLEX, ABUJA.

PROTOCOL

1. On behalf of the management of the Nigerian Institute of Advanced Legal Studies and the leadership of ILA-Nigeria branch, I would like to welcome you all to our week-long course.
2. Within the international society, law and diplomacy have always been complementary and interdependent. However, lawyers and diplomats deal with international issues differently. It is then a matter of common observation that between law and diplomacy there is an inevitable strain.

Diplomacy, like international law, is a Key part of our world as it seeks to prevent conflict, encourages the adoption of international Resolutions, promotes discussion and dialogue, and finds agreement through negotiation and common ground.

3. This interdisciplinary course is designed to help participants think critically about diplomatic and international legal issues in real-life contexts, while applying theory to practice and addressing some of the key questions facing the world today, and looking at contemporary practice and major events.
4. Its overall aim is to provide participants with the necessary knowledge and skills to understand that, if the study of diplomacy does not question the practice of invoking legal rules, there is a connection between the statement of the rule and the specific interest of the moment.
5. Key learning outcomes of this course include: - to understand and evaluate the interplay among the key legal, historical, political, ethical and other key factors that influence the evolution of international law; critically analysed the relationship between diplomacy, law and politics and existing interactions with international institutions; to craft a unique skillset to advocate for better solutions to the world's intractable challenges of : - Conflict prevention and resolution; triple planetary crises of climate change, biodiversity loss and pollution; displacement and human rights violations, amongst others.



Good Morning!

Introduction

I am highly delighted and honored to welcome you all to the opening of this milestone Advanced Course on International Law and Diplomacy which is organized by the Nigerian Institute of Advanced Legal Studies (NIALS) in partnership with our association, the International Law Association.

As you may already know, the ILA was founded in Brussels more than 150 years ago, in 1873 as a learned society dedicated to the study, clarification and development of international law and the advancement of peace, equity, and justice worldwide. Unlike the International Bar Association which is mainly for lawyers, membership of the ILA is open to lawyers and non-



lawyers that are interested in international law including diplomats, foreign policy experts, and practitioners in justice and international law departments. The ILA has consultative status, as an international non-governmental organisation, with a number of the United Nations specialised agencies. Just last month, I was in Greece for the global ILA conference, and last year in Paris, France for the celebration of ILA's 150 years anniversary. So, the ILA has members across the world, who participate through their local branches.

In recognition of Nigeria's preeminent role in public and private international law, the ILA approved the establishment of a Branch in Nigeria in 2014. The Branch was formally inaugurated by the then Chief Justice of Nigeria Justice Aloma Mariam Mukhtar, GCON at our first conference held in Lagos. Since 2014, the Nigerian branch of the ILA has provided the leading platform and intellectual space for Nigerian scholars and practitioners to unearth, analyze and resolve important questions in public and private international law, international diplomacy, and global governance.

Just in April of this year, we celebrated our 10th Year Anniversary as a Branch in a successful conference held here in Abuja. It was at that conference that ILA and NIALS cemented plans to provide opportunities for stakeholders and practitioners in Nigeria to gain more insights about the making and practice of international law.

As the saying goes, "If you don't write your story, someone else will tell it for you." For many years, international law has been largely shaped by western narratives. Our practitioners and lawyers have had to travel many miles to learn about international law, taught by foreign experts based on their own perspectives and legal systems. The end result is the gradual weakening of African perspectives in international treaty making. When I took over as President of the ILA, Nigeria last year, it was with a promise to equip the next generation of practitioners with the skills to reclaim that African voice at the global stage. Our country has produced many international law greats, including former judges of the International Court of Justice Charles Onyeama, JSC, Professor Teslim Elias, SAN the Prince Bola Ajibola, SAN and of course Chief Bayo Ojo, SAN, a former Attorney General of the Federation and member of the International Law Commission, who is our proud Patron of the ILA, as well as high level diplomats, such as our Chairman and Special Guest of today, whose work and impact transcend the shores of Nigeria.

Reclaiming the African voice in international law and diplomacy begins from home. A course like this provides a chance to develop and maintain a steady track of international law scholars and diplomats from Nigeria, for Africa and for the world.

International law has become ever so important in light of the complex challenges facing our current world. Ranging from the problem of climate change, wars and crises in Ukraine and Palestine, the associated water, energy and food poverty in many parts of Africa, and the complex challenge of maximizing the full value of intellectual property and modern technologies in a



manner that respects and fulfils international law standards amongst others.

Throughout this week, participants will be taught and inspired by experts skilled in the art and craft of international law and diplomacy on the roles we can play in being the the heart of fostering solutions. They will also have a chance to network, strategise and develop relationships that will enable them to launch and advance their careers in this important field.

I therefore encourage all participants to fully immerse themselves in the opportunities provided by this course.

I also want to take this opportunity to extend an invitation to those that are yet to join the ILA to please join us in advancing the study and practice of international law in Nigeria. The last page of your program contains more information about the Branch, as well as the membership application form.
